I am/we are familiar with and accept that there is always the risk of serious injury and death resulting from participation in any organized recreational activity particularly those involving towed water sport activities such as water skiing, wakeboarding, barefooting, marathon skiing, disabled skiing and like activities offered as part of the programme of *Water Ski and Wakeboard Canada and its associated provincial associations, member clubs and schools*, including its various related activities out of the water; and
2. I/we have satisfied myself/ourselves, and believe, that I am/we are physically, emotionally and mentally able to participate in this programme, and that my/our equipment, if applicable, is appropriate for use in this programme; and
3. I/we understand that all applicable rules for participation must be followed and that at all times the sole responsibility for personal safety remains with me/us; and
4. I/we will immediately remove myself/ourselves from participation, and notify the nearest official, if at any time I/we sense or observe any unusual hazard or unsafe condition or if I/we feel that I/we have experienced any deterioration in my/our physical, emotional or mental fitness, or that of my/our equipment, or exceeded my/our comfort level, for continued participation in any event or related activity.
